(Special Condition 10)

To : SmarTone Mobile Communications Limited  
Date : 30 September 2006

Pursuant to Special Condition 10 of the mobile carrier licence No. 091 granted to SmarTone Mobile Communications Limited on 30 September 2006 (“the Licence”), the Telecommunications Authority hereby directs SmarTone Mobile Communications Limited, until further notice is given in writing, to facilitate the portability of numbers assigned to any customer of a mobile carrier licensee, Public Mobile Radiotelephone Services licensee, Personal Communications Services licensee or Mobile Virtual Network Operator (MVNO) in Hong Kong and to arrange for the equitable sharing of all relevant costs associated with providing portability of numbers in accordance with the Code of Practice entitled “Code of Practice related to the Implementation of Mobile Number Portability (Issue 3)” issued on 12 July 2000 under section 32F(3)(b) of the Telecommunications Ordinance by the Telecommunications Authority (the “Code”), so that any number so assigned may be used by that customer should it cease to be a customer of any such entity and become a customer of any other mobile carrier licensee, Public Mobile Radiotelephone Services licensee, Personal Communications Services licensee or MVNO, as the case may be.

For the purpose of this Direction, unless the context otherwise requires, words and expressions shall have the meanings assigned to them in the Licence. The “Code” shall mean the code for the time being in force, as well as any modification or substitution of that code in whole or in part.

The Telecommunications Authority now forms the opinion that SmarTone Mobile Communications Limited is not in a dominant position with respect to the relevant telecommunications market for the service within the meaning of section 7L of the Telecommunications Ordinance. Pursuant to Special Condition 17.1 of the licence granted to SmarTone Mobile Communications Limited on 30 September 2006, the Telecommunications Authority hereby directs that, until further notice is given in writing, Special Conditions 14.4, 15 and 16 shall not apply to SmarTone Mobile Communications Limited. The Telecommunications Authority further directs that, until further notice is given in writing, Special Condition 14.2 shall not apply to SmarTone Mobile Communications Limited on condition that the tariffs for the service operated under the licence are published in the website of SmarTone Mobile Communications Limited.
