The Telecommunications Authority now forms the opinion that Pacnet Cable (HK) Limited (PCHKL) is not in a dominant position with respect to any market for telecommunications services provided under its licence within the meaning of section 7L(2) Telecommunications Ordinance (Chapter 106). Pursuant to Special Condition 24.1 of the licence granted to PCHKL on 8 February 2002, the Telecommunications Authority hereby directs PCHKL, until further notice is given in writing, the Special Conditions or any part thereof which impose the following obligations shall not apply to PCHKL:

- (1) Special Condition 7.4;
- (2) Special Condition 8;
- (3) Special Condition 9; and
- (4) Special Condition 10.

Pursuant to Special Condition 4 of the licence granted to Pacnet Cable (HK) Limited (PCHKL) on 8 February 2002, the Telecommunications Authority hereby directs PCHKL, until further notice is given in writing, to facilitate the portability of numbers for customers of public mobile radiotelephone services and personal communications services licensed under public radiocommunications service licences or mobile carrier licences in Hong Kong ("Mobile Number Portability") so that the Code of Practice entitled "Code of Practice related to the Implementation of Mobile Number Portability" issued under section 32F(3)(b) of the Telecommunications Ordinance by the Telecommunications Authority can be fully complied with on and after the launch of the service in accordance with Special Condition 25.1 of the licence.
