The Telecommunications Authority now forms the opinion that Telstra International HK Limited (TIHKL) is not in a dominant position with respect to any market for telecommunications services provided under its licence within the meaning of section 7L(2) Telecommunications Ordinance (Chapter 106). Pursuant to Special Condition 24.1 of the licence granted to TIHKL on 12 July 2007, the Telecommunications Authority hereby directs TIHKL, until further notice is given in writing, the Special Conditions or any part thereof which impose the following obligations shall not apply to TIHKL:

- (1) Special Condition 7.4;
- (2) Special Condition 8;
- (3) Special Condition 9; and
- (4) Special Condition 10.

Pursuant to Special Condition 4 of the licence granted to Telstra International HK Limited (TIHKL) on 12 July 2007, the Telecommunications Authority hereby directs TIHKL, until further notice is given in writing, to facilitate the portability of numbers for customers of fixed telecommunications network services licensed under the fixed telecommunication network services licences or fixed carrier licences in Hong Kong (“Operator Number Portability”) so that HKTA 2102 entitled “Procedures for Handling Number Porting by Database Solution” issued by the Telecommunications Authority and as revised from time to time by the Telecommunications Authority can be fully complied with on and after the launch of the service. All relevant costs associated with providing portability of numbers under this Direction will be equitably shared between the licensee, any other fixed carrier or fixed telecommunication network services licensee.

Pursuant to Special Condition 4 of the licence granted to Telstra International HK Limited (TIHKL) on 12 July 2007, the Telecommunications Authority hereby directs TIHKL, until further notice is given in writing, to facilitate, at TIHKL's own expenses, the portability of numbers for customers of public mobile radiotelephone services and personal communications services licensed under public radiocommunications service licences or mobile carrier licences in Hong Kong ("Mobile Number Portability") so that the Code of Practice entitled "Code of Practice related to the Implementation of Mobile Number Portability" issued by the Telecommunications Authority and as revised from time to time by the Telecommunications Authority can be fully complied with on and after the launch of the service.
