

Updated Gateway Prices and Modified Delivery Fees for Category B Routes

Statement of the Telecommunications Authority

19 July 2001

According to the Statement of the Telecommunications Authority (TA) entitled "Review of Gateway Prices and Modified Delivery Fees for Category B Routes" issued on 29 April 2000 (the "Statement"), Schedules 1 and 2 to the Determination of 30 December 1998 regarding gateway prices and modified delivery fees are revised as a result of the changes of accounting rates of the following routes:

- Macau
- Sierra Leone

2. Regarding the Macau route above, it is one of five routes having below-cost gateway prices, namely Cambodia, Korea DPR, Macau, Myanmar and Vietnam¹, as stipulated in the Statement. Pursuant to paragraph 35 of the Statement, the TA revises the gateway price and modified delivery fee of the Macau route having considered that the gateway price based on the methodology of the TA Statement of 25 November 1998 entitled "Local Access Charge and Modified Delivery Fee Arrangements" is found to be less than or very close to the current below-cost gateway price.

3. In addition, the existing exchange rate of HK\$7.796/US\$ used to determine gateway prices and delivery fees of certain routes falls outside the range of plus and minus one standard deviation from the mean for the past 12 months. According to paragraph 32 of the Statement, a revised exchange rate of HK\$7.798/US\$ based on the mean exchange rate for the past 12 month will be used for the month of July 2001. As a result of the exchange rate revision, the gateway prices and modified delivery fees of the following routes are in turn revised:

- Armenia
- Aruba

- Belize
- Diego Garcia
- Dominican Republic
- El Salvador
- Guatemala
- Haiti
- Marshall Islands
- Micronesia
- Palau
- Suriname

On the other hand, the existing exchange rates of HK\$10.161/SDR and HK\$3.319/GFC remain unchanged as they are within the range as described above. These exchange rates were calculated using the historical data of the respective exchange rates obtained from the Hong Kong Monetary Authority.

4. Following the issue of the TA Statement on 28 June 2001 entitled "Review of Local Access Charges", the Local Access Charges (LAC) have been revised with effect from 1 July 2001 including the LAC for incoming direct calls being revised from HK\$0.158/minute to HK\$0.126/minute. As this charge is one of the cost components to determine modified delivery fees² for Category B routes, the modified delivery fees of all Category B routes are therefore revised with effect from 1 July 2001 except three of the below-cost routes, namely Cambodia, Korea DPR and Myanmar. The TA finds that the revised gateway prices of these three routes after the LAC revision are still higher than the current respective below-cost gateway prices. In particular, the TA has again set the modified delivery fee for the Thailand route at the level of LAC for incoming calls of HK\$0.13/minute³.

5. The revised gateway prices and modified delivery fees effective from 1 July 2001 are tabulated in Schedules 1 and 2 as attached. In particular, according to paragraph 8 of the Statement, retrospective

³ In the TA Statement of 18 June 2001, the TA has set a lower limit for the modified delivery fee of the Thailand route at the level of local access charge for incoming calls of HK\$0.16/minute though the modified delivery fee of which would have been adjusted to HK\$0.10/minute due to revision of accounting rates. The TA considers that the modified delivery fee of any Category B route should not be lower than the local access charge for incoming calls determined by him for Category A routes.

settlement arrangement has been made for the Sierra Leone route, of which the effective date is 1 May 2001.

6. Further to the issue of the TA Statement of 24 December 1998 entitled "Local Access Charge and Modified Delivery Fee Arrangement – Classification of Routes into Categories A & B", of which the updated Appendices I and II are attached herewith giving the current "List of Category A Routes" and "List of Category B Routes on the Observation List" respectively.

7. A summary, which highlights the previous and revised gateway prices and modified delivery fees of the above routes as well as their respective effective dates, and the exchange rates statistics for the past 12 months, is given in the Annex.
